## GENERAL CONDITIONS OF SALE

### Conditions of participation

The attribution of the booths will respect, subject to availability, the elements informed on the participation file.

### Reminder :

- In case of acceptance of the application for the participation in the exhibition by the organizer, the organizer and the exhibitor are definitely committed to each other.
- In order to benefit from the preferential rate, the exhibitor must pay the first deposit before May 20, 2023.
- From May 20, 2023, the basic rate of 8500 DHS excluding VAT will apply.

### Subscription :

To become an exhibitor, you must return to COULEURS COM the reservation form duly completed, dated and signed. The signature constitutes a firm commitment and obligate the subscriber to accept the general conditions of the partnership file and the technical file (transmitted later). Moreover, the attribution of the booth is valid only with reception of a deposit of 50%. Any reservation made before 20/05/2023 must be accompanied with the payment of the 50% deposit of the total amount including VAT. The balance must be paid no later than 20/05/2023. For any reservation made after 20/05/2023, the amount is due at the order.

### Cancellation and disputes :

In case of cancellation before 20/05/2023, an indemnity of 50% of the amount of the order will be kept. If the cancellation occurs after this date, the total amount of the order remains due and will be preserved as compensation of the cancellation.

If the Aromaplantexpo cannot take place due to any external circumstances, the exhibitors undertake not to claim any compensation from the organizers. The remaining funds after the payment of all the expenses incurred will be divided among the exhibitors in proportion to the amounts paid. In case of dispute, only the morrocan court is subject to resolve any legal issues.

### Occupation of the exhibition areas:

The registration file is nominative. It is forbidden to share, to give up or to sub-rent all or a part of the site. The plan of the exhibition is established by the organizer. No complaint will be accepted concerning the location of the booths and exhibitors agree to comply with the decisions taken. The same applies if, for imperative reasons, the organizer has to modify the locations or the installations or schedules.

The allocation of the booths will be made in the order of the arrival of reservations. After allocation, no modification can be made without the agreement of the organizer.

Exhibitors will take the premises in the state in which they find them and must leave them in the same state. All damage caused to their installations and decorations or due to their installations, their decorations, their staff and subcontractors, are their responsibility. They will be responsible directly to the host site, the organizer can in no case be considered responsible.

### Sponsoring :

The possibilities of sponsoring being limited, the organizer will grant the requests which will have been addressed to him before the date appearing on the purchase order. The orders of reservation will be honored according to their rank of recording and their availabilities.

### Insurance and Legal Liability

Each exhibitor participating in Aromaplantexpo is required to have an insurance policy that covers him for :

- Damage to third parties, including other exhibitors, for which he is personally responsible.
- Damage to materials and products exhibited at the exhibition.
- Aromaplantexpo is in no way responsible for thefts (goods, personal items) of which the various participating exhibitors at the booths are victims.
